Meeting Minutes

1. Welcome & Declarations of Interest

The Chairman called the meeting to Order at 0937 hrs.

There were no conflicts of interest recorded.

2. Minutes of Last Meeting

The Minutes of the General Meeting held on 15 February 2024 were agreed as amended.

3. ICEO Report

ICEO discussed his report with the Members. Chair requested a new item 'Committees' on the Agenda moving forward. **BS to action**.

CFI job description – ICEO explained this had to be re-drafted due to changes in the position since the last advertisement. In particular the post no longer requires the holder to sit on the Board. Current salary grade remained an issue, and it was intended a consultation with the Ministry would go ahead to change the grading for the post. Recruitment had been discussed at the HR Committee Meeting earlier in the week. ICEO confirmed after questions from Members, that OfReg do use a recruitment agency.

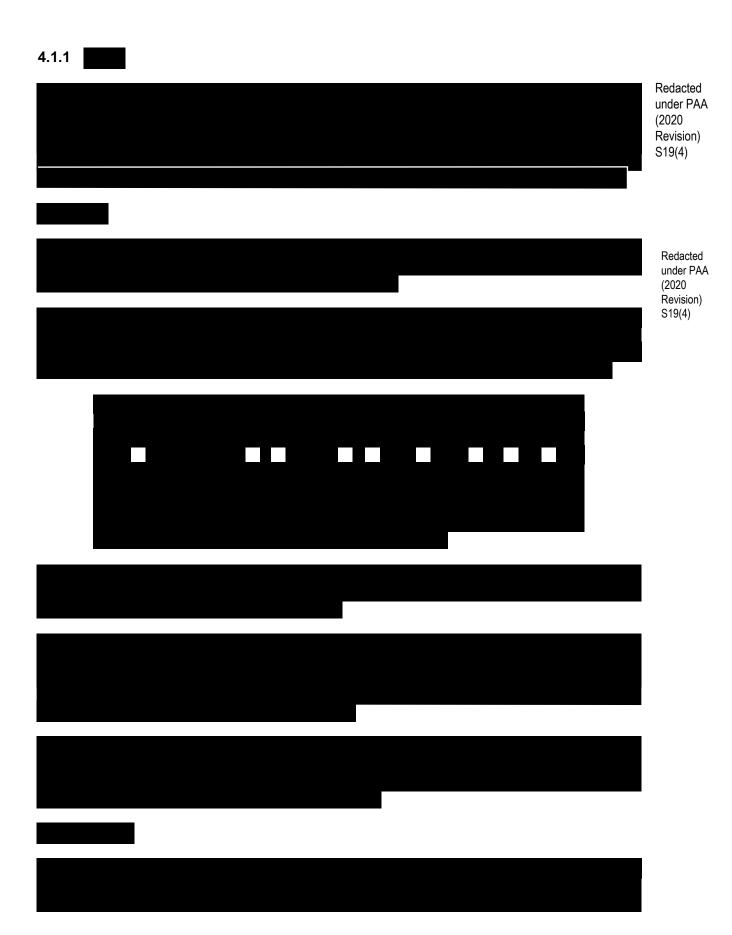

Fuel Sector AOB

Refuel's importation of fuel was discussed by the Board.

They could effectively be bringing in any fuel of any quality at this time. DCFI said

they were purchasing the fuel from 'jobbers' and not a specific supplier, and so they do not receive quality certificates on what they are purchasing. Effectively argument for not supplying certificates is due to who he purchases from. There is a storage certificate issued to under PAA for a site on Lagoon Drive in the industrial park, but this is only a small site. None of the two gas stations being run, have storage permits, however there is no gas currently stored on the new site behind the Ritz.

DCFI indicated the rationale behind his importing fuel was that the fuel would come onto the Island, be offloaded into the station and the empty totes returned to the Port, however the Port now claim they have no space to store them. OfReg speaks to the capacity of the tanks on regulated premises, whether they are empty or not. It was pointed out he also offers mobile fuelling. ICEO confirmed that he was appointed Acting CFI and had delegated signing responsibilities to DCFI.

5. Board Matters

5.1 IT Strategy

IT Manager came into the meeting and presented a plan for the change to OfReg's current technological requirement. Once the presentation was given to the Board, it was their view the IT department would need further staffing in order to function effectively. This project will be reviewed and reported up to the Board. GB believes this is a difficult migration and he would like to become involved in this, as some members of the Board had reservations about owing a second laptop and phone to deal solely with OfReg business.

5.2 Changes to Non-Disclosure and Restricted Deed Agreement

This would be dealt with by the BS sending a round robin email.

5.3 Proposed Amendment to WA Act

This will be deferred to the April meeting.
