- Licence Types are defined in a Section 23 Notice published from time to time in the Gazette by the Office, a copy of which is available on the Office's web site at www.ofreg.ky.
- You should use this form (OfReg Form J) if you wish to apply for an Amateur Radio licence for the Cayman Islands and hold an overseas licence.
- This form must be accompanied by:
 - the appropriate fee (currently CI\$20/US\$25 per annum).
 - photo identification, and
 - a certified copy of your current home Amateur Radio licence.
- The Cayman Islands is a signatory to ECC Recommendation T/R 61-01. Any Amateur Radio licensees from countries listed in, and meeting the criteria of, the recommendation do not need to apply for a local licence and may operate as 'ZF/[home callsign]' for up to 3 months.
